## CONSENT ORDER

On August 22, 2019, members of the Maryland Medical Cannabis Commission (the "Commission") held a pre-charge Case Resolution Conference ("CRC") with K. B. (the "Respondent"), a certified patient, pursuant to its authority under Md. Code Ann., Health-Gen. § 13-3301 et seq. (2015 Repl. Vol. and 2018 Supp.). The purpose of the CRC was to attempt to reach resolution of a case in which the Respondent allegedly diverted medical cannabis when he stole from a licensed dispensary.

The pertinent provision of the relevant statute states:

- § 13-3313. [P]enalty for distributing, possessing, manufacturing, or using diverted cannabis.
- (b) (1) A person may not distribute, possess, manufacture, or use cannabis that has been diverted from a qualifying patient, a caregiver, a licensed grower, or a licensed dispensary.
- (2) A person who violates this subsection is guilty of a felony and on conviction is subject to imprisonment not exceeding 5 years or a fine not exceeding \$ 10,000 or both.
- (3) The penalty under this subsection is in addition to any penalties that a person may be subject to for manufacture, possession, or distribution of marijuana under the Criminal Law Article.

In lieu of proceeding with an evidentiary hearing in this matter, the parties agreed to the following Findings of Fact, Conclusions of Law and Order as set forth herein.

FINDINGS OF FACT

The Commission finds that:

On March 9, 2019, the Respondent went to a licensed medical cannabis dispensary

in Germantown, Maryland to seek reimbursement for a product that he had purchased there. The

general manager spoke to the Respondent and, because of the general manager's personal

experience with the Respondent, the general manager offered the Respondent a discount on a

future purchase but did not reimburse the Respondent for his prior purchase.

2. During the Respondent's conversation with the general manager, the Respondent

asked the general manager to show him an item for sale in the patient area, a container containing

1/8g of medical cannabis flower, worth about \$50.00. As the general manager showed the

Respondent the container, the Respondent took it from the general manager's hands and left the

dispensary.

3. The general manager then contacted the Montgomery County Police Department

and filed a police report. The Montgomery County State's Attorney issued criminal charges

against the Respondent for misdemeanor theft.

4. On June 13, 2019, the Respondent appeared for trial at the Montgomery County

District Court. The dispensary employee who had appeared to serve as a witness was unavailable

for the length of time needed for him to testify at the Respondent's trial later that day. As a result,

the district court judge dismissed the criminal case against the Respondent conditionally.

5. The district court judge's conditions for dismissing the criminal case against the

Respondent included requiring the Respondent to pay restitution to the dispensary and to stay away

from the dispensary. As of August 22, 2019, the day of the CRC, the Respondent has fully

complied with these conditions.

6. Respondent has an ongoing need for access to medical cannabis.

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Commission concludes as a matter of law

that the Respondent diverted medical cannabis in violation of the Maryland Medical Cannabis

Law, Health-Gen. § 13-3313.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law by the Commission, it is

hereby

ORDERED that beginning on the date this Order is signed by the Commission Chair, the

Respondent's patient certification shall be SUSPENDED for a period of twenty-four (24) months;

and it is further

ORDERED that this SUSPENSION shall be STAYED for a probation period of twenty-

four (24) months but that this stay may be lifted and the suspension fully imposed at any time by

the Commission or by a group of Commissioners meeting as a committee or during a later CRC,

for good cause shown;

ORDERED that should the Respondent commit any infraction or violation of the law

during the probationary period described above, the Respondent's certification shall be

**REVOKED**, subject to a show-cause hearing; and it is further
